
### Overall

- Current new case rate is **25.9 per 100k** for Buckinghamshire (**141 cases**)
- 20.6% of cases this week were identified through asymptomatic screening (LFTs)
- 29.5% of cases this week were linked with foreign travel
- South East **R number 0.6 to 0.9**; England 0.7 to 1.0


### Age Groups

- Highest new case rates in Buckinghamshire for the 30-44 year age group
- Largest weekly increase for residents aged 30-44 (16.2% increase from 37 to 43 cases)
- Rates for 60+ cohort have reached a plateau with 9 cases overall for the week

# Education and Early Help Update

# Early Help

- School-Linked Family Support Workers are available to discuss emerging concerns and partnership responses, hold professional meetings regarding next steps for families of concern or prior to submission of a MARF where threshold discussions would be helpful.

- Family Centres are re-opening after the Easter break – drop-in sessions and group activities will be available with a developing programme of events and activities at all Family Centre sites. FSS are keen to work with schools and local community groups to ensure the offer reflects local needs and priorities. Contact your Community Coordinator via BFIS.

# Achievement and Learning

- Buckinghamshire Challenge – we continue to deliver conferences and workshops for schools which are very well attended with positive feedback from all participants
- Secondary School Transition – Working party of primary and secondary schools will deliver agreed revised protocols for summer 2021 by the end of April
- Kingsbrook school: Insignis is agreed as sponsor and work is on track for September 22 opening
- Secondary allocations: Second round has ensured that every child has a place

# Ofsted Updates – Summer 2021

- Monitoring inspections will resume for schools that are graded 'Inadequate' and those graded 'Requires Improvement' at their last two consecutive full inspections.
- Section 8 inspections for 'good' schools that have not had an inspection within 5 years will recommence this term.
- 'Outstanding' schools will be able to request an inspection.
- These arrangements commence on May 4<sup>th</sup> for primary schools and after half term for secondary schools .
- Ofsted is undertaking a review into safeguarding policies and practices relating to sexual abuse in schools this half term. This is linked to anonymous testimonials of abuse published on the website 'Everyone's Invited'.

# Special Educational Needs and Disabilities

- 96% of schools named for children with EHCPs going through phase transfer (starting school for the first time, infant to junior, primary to secondary) by the statutory deadline of 15<sup>th</sup> February.
- Annual review training delivered to all schools by area, as well as one special school specific session, in March 21, launching new paperwork which has a greater focus on progress towards outcomes as a core element of annual reviews.
- New schoolsweb pages launched for SEN as a one-stop shop for accessing advice, support and guidance: [SEND and Inclusion | SchoolsWeb \(buckscc.gov.uk\)](https://www.buckscc.gov.uk/schoolsweb/SEN-and-Inclusion)
- Portal pilot launched in spring term with a few schools, trialling the EHC needs assessment process through this system.
- Speechlink joint commissioning arrangement to support 5-7 year olds in infant and primary schools has been extended until August 2022 to facilitate embedding of the programme, and greater impact on children.

# Children's Social Care

# Ofsted unannounced visit – social care – February 2021

- Strong partnership arrangements have ensured the provision of support to the most vulnerable children in Buckinghamshire throughout the pandemic.
- Leaders have an accurate understanding of the service and have maintained a firm focus on doing the best for children and families.
- The senior leadership team has focused relentlessly on the well-being of the workforce. Staff value the exceptional support that they have received from leaders and managers and talked positively about working for Buckinghamshire.
- The recruitment and retention of a stable workforce rightly remain the top priority in the local authority's improvement plan.
- The Multi-Agency Safeguarding Hub (MASH) provides a proportionate response to initial concerns about children.
- Threshold decisions about the provision of early help are proportionate, and transfers between early help and children's social care are managed well.

# Ofsted unannounced visit – social care – February 2021

- Leaders have developed clear expectations about visiting children during the pandemic, including returning to face-to-face visiting where possible. Most children are visited in accordance with their needs; however, despite improving practice in this area, visiting is not always timely for some children.
- The local authority and schools have worked together well since the start of the pandemic.
- The pre-proceedings phase of the Public Law Outline is used effectively to safeguard children; however, some practice shortfalls lead to some delays that are not purposeful.
- Children in care have continued to make some progress despite the challenges presented by the pandemic. Most live in stable homes that meet their needs, with carers who are committed to them.
- Care leavers benefit when they have established relationships with personal advisers, but this is not always possible given changes in the workforce. For some, this negatively affects the progression of their plans.

# Ofsted unannounced visit – social care – February 2021

- Leaders have strengthened commissioning arrangements. This is beginning to deliver results, with greater scrutiny of unregulated provision and the vast majority of care leavers now living in suitable accommodation.
- Although management oversight is now routinely evident on children's files, actions arising are not consistently followed up, leading to delays in some children's plans being progressed.
- Audit and quality assurance activity needs to be embedded and completed alongside practitioners to drive quality of practice.
